Mica coated with Titanium Dioxide, Iron Oxide and Ultramarine Blue - other component(s) Tin Oxide

SECTION 3 - Hazards Identification

Skin Contact: Non-hazardous.

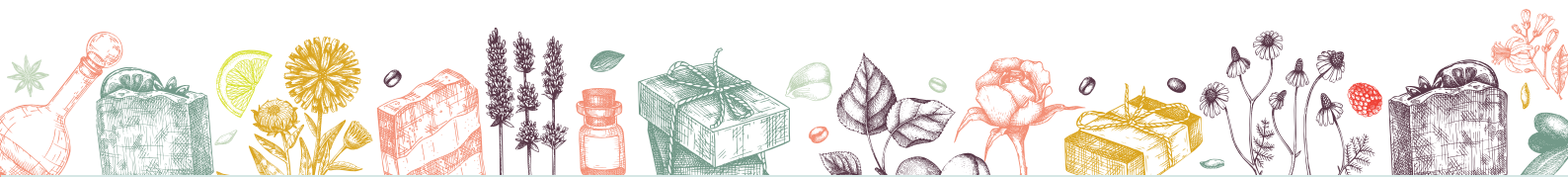
